The diversity curriculum will involve proactive programs, activities, videos and role playing. What will the role playing entail? Some of these programs have a boy wearing a dress come into the classroom to get reactions from class members! Again, the AFA of PA believes that ALL students should be free to learn without fear of being harassed or bullied. BUT the Southern Poverty Law Center has a history of being very pro-homosexual. Do your children need to be indoctrinated that ‘gay is okay’ --students should not be asked to embrace this dangerous lifestyle as normal.

This issue involves not only parents, but any taxpayer in the Franklin Area School District. The Southern Poverty Law Center material was free of charge, but part of a taxpayer-funded school day will be used to present this questionable curriculum.

This spring the AFA of PA worked with Mission America on the Risk Audit Project which was designed as a tool to investigate schools for homosexual activism. Do the actions of the Franklin district warrant additional investigation? What you can do

- 1.) Ask to preview the diversity videos and curriculum – it’s your kids and you’re paying for it! What is the overall tone of the material – does it attempt to reverse gender roles, does it ‘celebrate’ homosexuality and same-sex households, does it equate homosexual ‘rights’ with civil rights, does it undermine parental authority, is the message ‘gay is okay.’
- 2.) Attend Monday night’s (July 24) school board meeting at 7:00 p.m. in the Sandy Creek Elementary library.
