News From Around PA
University of Pittsburgh has
determined "transgender
students must use the
facilities that match the sex
on their birth certificates."
The Pittsburgh Commission
on Human Relations said

**Senate Bill 354**, Senator Mike Folmer's proposal to exempt PA from mandates of federal REAL ID, now goes to Governor Corbett's desk.

and Human Services thanks to Obamacare! The funded program "teaches parenting skills and helps new mothers and fathers cope with the responsibilities of parenting, provides home visits and addresses issues that can lead to (child) abuse."

New from National Scene War on Illegal Pornography Coalition, of which the AFA of PA is a part, sent a letter to Congressman Fred Upton, Chairman of Energy Commerce and Senator Lamar Smith, Chairman of the Judiciary on April 4th. The letter asked for Congress to hold hearings on the harm from pornography and the need to vigorously enforce US prohibiting laws distribution of obscene adult porn as the US Dept of Justice has stopped all enforcement of these law.

Romania has highest abortion rate in Europe - 480 abortions for every 1,000 live births, or more than twice the EU average. The organization representing Planned Parenthood receives 70 percent of its budget from

USAID the U.S. government's foreign aid agency.

Blue Cross Blue Shield has been ordered by Obama administration to cover the same-sex spouse of a federal employee noting the February ruling of US District Judge Jeffrey White declaring the Defense of Marriage Act unconstitutional.

Miss Universe Organization has reversed its previous decision and will allow a "transgender woman" to participate - that means a man who believes he is a woman will compete!

Human Rights Campaign reports the number of major U.S. companies covering cost of sex reassignment surgery for "transgender" workers has more than doubled in the past year - from 85 in 2010 to 207 in 2011.
