News From Around PA
The AP reports three of
Pennsylvania's 500 public
school districts are on strike:
Lackawanna County's Old
Forge School District,
Luzerne County's Wyoming
Area School District and
Allegheny County's Shaler
Area School District.

New Hope Borough, (Bucks County) Register of Wills has refused to perform same-sex 'marriages.' However, in New Hope the Raven held a Summer Poolside Show to Benefit PA Marriage Equality.

Bristol Borough (Bucks County) is looking at a socalled anti-discrimination ordinance which would include 'sexual orientation and gender identity.'

Fifty-two locations in Connellsville have requested Ten Commandment monuments on their property. So far the Thou

Shalt Not Move group has raised money for 14 monuments. In the meantime, the Connellsville School District and Freedom From Religion Foundation continue the legal fight over the 50 year old monument on school property.

News from National Scene Two admitted homosexual activists who recently got a civil union in New Jersey are expressing outrage because the Ohio-based company one of them works for will not recognize the civil union and permit his partner to be added to his health care coverage. They see this as a need for same-sex "marriage" nationwide: "We need our congressmen and senators to act on a federal level to fix this once and for It's all. totally unacceptable situation, and one [that] I don't want to fund with my tax dollars."
