New from National Scene OutSports.com editor Cyd Ziegler is calling for an end to Chick-fil-A sponsorship of the Chick-fil-A Kickoff Game and the Chick-fil-A Bowl. He called the Chick-fil-A logo a symbol of oppression and legalized discrimination.

The Heritage Foundation reports that **Dodd-Frank** banking regulations, which turned two on July 21st, are strangling the economy. It created Consumer the Financial Protection Bureau that has unparalleled powers and swelled the ranks of regulators by 2,849. It does not end bailouts or taxpayer support of big banks, but permits the FDIC to purchase the assets of a failing bank, guarantee its obligations, take a security interest in its assets, and borrow on the failed firm's total consolidated assets. For Bank of America, that would be \$2 trillion in bailout authority paid by taxpayers!

In a 2011 interview with Lisa Ling **Exodus International President Alan Chambers** states: "There are people out there who are living an active gay Christian life. God is the one who called them and has their heart and they are in fellowship with Him, and I do believe they will be in heaven with me." In January he addressed the "Gay Christian Network" (GCN) conference stating Exodus must change its motto from "change is possible" because complete change is not possible! Dr. Robert Gagnon, Associate Professor of NT at the Pittsburgh Theological Seminary, has called for Chambers removal, but don't expect that to happen as he has stacked his board with people who agree with him.
