News from National Scene Recently a California Boy Scout announced he is homosexual. Last month his application for Eagle Scout was approved by a volunteer review board, which then forwarded it to the local Scout Council. The local council rejected the application because he is over 18 and "this young man proactively stated that he does not agree to Scouting's principle of 'Duty to God' and does not meet Scouting's membership requirements. Therefore, he is not eligible to receive the rank of Eagle." Homosexual activist groups are hoping to pressure the BSA into approving the application.

The Washington DC **National Cathedral**, an Episcopal congregation, announced it will implement a new "rite of marriage" for its homosexual members. The Very Reverend Gary Hall, says, "I think it is an important symbolic moment."

On December 21st the **Ninth Circuit Court of Appeals** blocked the California ban on change therapy from going into effect when it granted an injunction pending the appeal in Pickup v.
