News From Around PA Chambersburg Area School District board has given a temporary okay to a Gay Straight Alliance Club, in order to avoid an ACLU lawsuit. The final decision will be make at the next board meeting on March 27.

Dan Miller, the openly homosexual city controller of Harrisburg, was recently in Philadelphia to raise monies for his campaign for mayor of Harrisburg.

University of Pennsylvania LGBT Pride celebration runs March 17-24 on campus and throughout the city. QPenn is organized by Lambda Alliance, the umbrella group for campus LGBT groups.

Kermit Gosnell's House of Horrors trial has begun. This

Allyson Robinson, a Scranton native, is the first executive director of OutServe/ Servicemembers Legal Defense Network. He is a "transgender woman, an Army veteran, a mother and a wife" who is working for the repeal of the federal Defense of Marriage Act and the "full inclusion of trans individuals" in the military.

Over 200 companies sign onto an amicus brief asking the US Supreme Court to overturn California's Proposition 8 and the federal Defense of Marriage Act.

Obama has nominated **Todd Hughes** for federal appeals court. "If confirmed, (he) would become the first openly gay federal appeals court judge in U.S. history," said Chuck Wolf of The Gay & Lesbian Victory Fund.
