News From Around PA

A ministry called **Stop Stericycle** has learned what happened to many of the babies, late-term and otherwise, who were aborted by Philadelphia's Kermit Gosnell. Stericycle, a company that disposes of medical waste, did so for Gosnell's Philadelphia abortuary. Even though the babies were to be incinerated, many of them ended up in PA's landfills, which is against the law.

Pro-abortion **Emily's List** has endorsed Allyson Schwartz for PA Governor for 2014.

Election of open homosexual candidates in the primary: Out Democratic candidate for Hatboro Council Andrea Myers will head to the general election in the fall, as will Chris Dietz, an openly gay Democratic candidate

for Millersburg Borough Council, and Ben Allatt for Harrisburg City Council. Also successful were incumbents Lori Schreiber for reelection to the Abington Township Commission and Robert Langley to Meadville City Council.

News from National Scene

The **US House** voted on a repeal of Obamacare for the 37th time. Two Democrats joined 227 Republicans in voting for repeal.

The Senate "**Gang of 8**" released the 844-page immigration bill. It creates three new amnesty programs, including a blanket amnesty for illegal aliens who entered the country before December 31, 2011; a DREAM Act for certain illegals who entered the U.S. before age 16; and a special AgJobs amnesty for illegal aliens who can establish that they have worked in agriculture for a certain period of time. It also further rewards illegal immigrants by expanding the "guest worker" program.

Lambda Legal joined the ACLU, the National Center for Lesbian Rights and the

Transgender Law Center in "expressing very grave concerns with the religious exemption in ENDA. It could provide religiously affiliated organizations—far beyond houses of worship—with a blank check to engage in employment discrimination against LGBT people."

In response to a request from a transgender "woman," the federal **Centers for Medicare and Medicaid Services** has announced it has launched a formal "reconsideration" of its current refusal to cover surgical treatment for gender identity disorder" i.e. sex reassignment surgery.
