**News From Around PA**

Adrian Shanker, president of the homosexual group **Equality PA** plans to marry his boyfriend next year in a state which recognizes same sex "marriage." Shanker said they see their "wedding" as having "significance beyond the personal realm." They also plan to apply for a marriage license in Northampton County and display the rejection letter next to their legal marriage certificate at a local Jewish wedding ceremony.

**Community College of Allegheny County** is slashing the hours of 400 adjunct instructors, support staff, and part-time instructors to dodge paying for Obamacare. Full-time workers will be slashed to below 30 hours and temporary part-time workers

to 25 hours. The 'answer' according to United Steelworkers representative Jeff Cech, is that "adjunct professors should unionize in an attempt to thwart schools seeking similar cost-savings efforts."

Four women who sued **Philadelphia** for jailing them in the same cell with a "transgender woman" have received \$8,000 each from the city to settle the case. They claim their privacy rights were invaded when they were forced to be housed with this anatomically correct male who just happens to think he is a woman. They say they were subjected to unwanted advances and sexual harassment.

**News from National Scene**

On November 19th a federal judge rejected **Hobby Lobby Stores Inc.**'s request to block part of the federal health care overhaul that requires the arts and craft supply company to provide insurance coverage for the morning-after and week-after birth control pills.

John Schnatter, CEO of **Papa John's Pizza** announced he

will be forced to cut back workers' hours because of the cost to businesses of Obamacare. Companies which have already made that move include Kroger grocery stores, Darden Restaurants (the chain that runs such outlets as Red Lobster, Olive Garden, LongHorn Steakhouse and others), St. Jude Medical, Boston Scientific, medical device manufacturer Stryker.

**The UPS Foundation** gave more than \$85,000 to the Boy Scouts in 2011, according to its tax return. They will no longer give these grants because the BSA does not permit homosexual leaders or members.
