SB 732 - the bill to regulate abortion clinics in the same way as other medical facilities has not yet come to a vote in the House. It is again on their calendar.

Challenge to Pennsylvania's Defense of Marriage Act - The case *Cozen O'Connor v. Tobits*, No. 2:11-cv-45 (E.D. Pa.) is currently pending in the US District Court for the Eastern District of PA. House Res 13 was aimed at "supporting and encouraging the public display of the national motto in all public buildings, public schools and other government institutions." Democrats in the House Judiciary Committee called it unnecessary and divisive. However, Congressman Randy Forbes gave numerous examples of why it was so desperately needed. On November 1st the resolution passed by a vote of 396 to 9!

S598- Respect for Marriage Act would overturn our federal Defense of Marriage Act. On November 3rd the Senate Judiciary Committee began debate. A vote in committee is scheduled for November 10th. If it passes, it will go to the full Senate.
