### News From Around PA

The parents of a 7th grade girl is suing the **Line Mountain School District** (Northumberland County) saying she's being denied the opportunity to wrestle on the middle school team because of her gender.

Recently **Newberry Township** (York County) received a letter of complaint accusing them of unconstitutionally opening their meetings in prayer. The Board of Supervisors has now moved prayer to the public comment portion of their meetings where someone from the public is always there to voice a prayer.

**Susquehanna Township School Board** is considering a

policy regarding employees' freedom of speech outside of the school setting.

**St Luke's University Health Network** in the Lehigh Valley is reviewing its policy of not offering health benefits to "married" same-sex couples. This announcement was made after the PA Diversity Network delivered 1200 letters asking for the change.

### News from National Scene

Defense Secretary Chuck Hagel has sharply criticized U.S. states that are defying the Pentagon by refusing to allow National Guard facilities to issue ID cards that enable same-sex "spouses" of military members to claim benefits.

Nomination of radical nominee for **DC Circuit**, Patricia Millett, has been blocked in the US Senate.

A **Bloomberg** government analyst put the Obamacare website rollout cost at \$1 billion, not the \$600 million price tag usually stated.

The United States Postal Service is honoring **Harvey Milk** on a commemorative stamp. Viewed in the 'gay'

community as a hero, he was the first open homosexual to be elected to public office. However, closer study of Milk's life reveals he was a serial rapist of young boys!

The **Employment Non-Discrimination Act** (ENDA) passed in the Senate by a 64 to 32 vote. Senator Casey was a co-sponsor and Senator Toomey voted 'yea.' Businesses with 15 or more employees will be forced to hire homosexuals, bisexuals and transgenders. Prior to the vote, Senator Toomey's religious exemption amendment was defeated.
