<u>News from National Scene</u> An attempt to kick a Child Evangelism Fellowship club out of the **Cascade School District** in Washington State was recently thwarted.

A federal appeals court ruled 3-0 that a Texas school board does not violate the U.S. Constitution by beginning its meetings with student-led prayers. Since 1997, the **Birdville school board** has allowed students, typically in elementary or middle school, to open board meetings with prayer, often referring to Jesus Christ and inviting audience members to pray. The court said the board meeting was "more like a legislature" rather than a classroom and cited the U.S. Supreme Court's 2014 decision, allowing the Town of Greece in upstate New York to start board meetings with prayer. The lawsuit was brought by the American Humanist Association.
