News From Around PA Both the ACLU and attorneys for the Commonwealth have asked Judge John Jones to issue a summary judgment the case defending in marriage rather than have a jury trial scheduled to begin on June 9th. According to the April 22nd Harrisburg "A trial Patriot News: became unnecessary after Commonwealth the indicated it would not call experts to counter the argument from plaintiffs that there is no rational reason why lesbian and gay couples are excluded from marriage.
