News From Around PA

A review of **Planned Parenthood** facilities in Pennsylvania has found no evidence of wrongdoing, the State Health Department announced.

Bills to add "sexual orientation and gender identity or expression" to the **PA Human Relations Act** have been reintroduced. New tactic is to call it the "Pennsylvania Fairness Act."

Despite charges that he illegally spied on colleagues' emails, the head of PA **Attorney General** Kathleen Kane's security detail will remain on the job.

Governor Wolf has called on Attorney General Kathleen Kane to step down after criminal charges against her were filed.

Three PA universities made the top 15 party schools for 2015, according to **The Princeton Review**. They are Bucknell University - 4th, Lehigh University - 11th, and Penn State -- 13th.

News from National Scene

Chaplain David Wells was told he could either sign a state-mandated document promising to never tell inmates that homosexuality is "sinful" or else the **Kentucky Department of Juvenile Justice** would revoke his credentials. He could not sign the document and the KY Dept. of Juvenile Justice revoked his volunteer credentials as an ordained minister – ending 13 years of ministry to underage inmates

The Evelyn & Walter Haas, Jr. Fund, the Gill Foundation, the Proteus Fund, the David Bohnett Foundation, the Arcus Foundation, and the Ford Foundation have contributed \$4.8 million to the cause of **suppressing religious rights** by forcing religious organizations to accept same sex "marriage."

Defense Secretary Ash Carter announced the formation of a working group tasked with

looking at whether **transgender troops** can serve openly. Carter called the ban on transgender service members "outdated" saying it distracted from the military's "core missions."

Wheaton College will stop providing student health insurance because they refuse — for religious reasons — to abide by the contraception provisions mandated under Obamacare.

Hope College in Holland, MI, which is affiliated with the Reformed Church in America and Belmont University, a nondenominational school in Nashville, TN, have extended employment benefits to same-sex couples.
