News From Around PA

PA Choose Life License Plates were approved in 2007, since then 1,430 have been sold bringing in \$28,600. Membership for **PA Choose Life** is \$52.00 per year for the first year. The membership fee includes the PA Choose Life License Plate. After covering the costs incurred from Penn DOT for the plates the rest of the \$52.00 fee goes directly to charities supporting pro-life causes and those in crisis pregnancies. PA Choose Life, Inc. asks that you renew your \$20.00 membership fee each year at the time of your vehicle registration.

SB 3, the Pain Capable Abortion Prevention Act and **ban on dismemberment abortions** passed in the State House by a vote of 121 to 70. Click here to read how your House member voted.

It now heads to Governor Wolf's desk.

News from National Scene

Treasury Dept. found that **pretax household income of same-sex married couples** is higher than that of heterosexual married couples. Mostly driven by the average earnings of male same-sex couples: \$176,000. On average, they make \$52,000 more than married lesbian couples and \$63,000 more than married "straight" couples.

2ndVote released tax documents revealing that the **NFL Players Association** donated \$5,000 in 2015 to the Center for Community Change Action, which receives money from many leftist, including George Soros. Its website boasts that it "drives thousands to attend rallies and participate in the immigration reform movement, uplifts the stories of DREAMers and immigrant families, and catalyzes online activism and real-world action for compassionate, humane immigration reform that includes a path to citizenship."

To continue this "tradition" the NFL as negotiated a seven-year deal with the activist **Players Coalition**. The nearly \$90 million is going mainly to liberal groups such as Van Jones' Dream Corps, a "social justice accelerator."

The **US Supreme Court** has refused to hear a case where a lesbian claims to have been fired because of her homosexuality. It sought to expand the definition of 'sex' in Title VII to include "sexual orientation."

Texas businesses will not be forced to give **spousal benefits** to employees in same-sex "marriages" after the U.S. Supreme Court refused to hear the issue.
