**News From Around PA**

Forty-five teachers in the **Harrisburg School District** have resigned recently, claiming students acted violently towards them. (And taking God out of the schools has no negative consequences??)

The **City of Reading** voted unanimously to take away the rights of parents who may have a child with unwanted same-sex attraction or gender confusion and who desire to have counseling to help them work through the reasons behind the confusion. Counselors within the city are only permitted to give 'gay-affirming' or 'transgender-affirming' counseling.

Governor Wolf has vetoed SB 3, the **bill to ban abortions** after 20 week and to ban dismemberment abortion.

He said, "SB3 is an attack on women. It's an attack on their health, their freedoms, their choice, their liberties." An attempt to override is unlikely.

PA's Attorney General, **Josh Shapiro**, is suing the Trump administration after it issued a rule making the contraceptive mandate exemptions broader. One of the groups impacted is the Little Sister of the Poor, but Shapiro won a court order keeping them from joining the case to defend their rights!

Only 6 State Senators voted against the **CHIP program** which will use tax dollars for "sex reassignment" surgery for children in it. They were Senators Aument, Disanto, Eichelberger, Folmer, Hutchinson and Martin.

**News from National Scene**

A lesbian couple was "married" in **Kern County, California** last December. It was not until this August they walked into a bakery owned by a Christian and wanted her to bake them a "wedding" cake. She

declined citing her religious beliefs and offered to set up an appointment with a competitor. They declined the offer, left the store and immediately started a hateful attack on social media. The Dept. of Fair Employment and Housing filed a motion to forbid her "from selling to anyone any item they are unwilling to sell." A Superior Court Judge denied the state the restraining order.
