News From Around PA
PA collected \$2.4 billion in **General Fund** revenue in January, \$43.5 million, or 1.8 percent, less than anticipated, which put the commonwealth \$40.9 million, or 0.3 percent, below estimate for the first seven months of this fiscal year.

Grove City Area school board is considering the addition of "sexual orientation" to district harassment policies. A student has also asked for permission to start a GSA homosexual club.

The PA Lottery is ready to roll out Keno by the end of the year, but the Revenue Department first wants to permanently reduce or at least see a long-term reduction of the minimum profit percentage the Lottery

is required to put toward programs for senior citizens.

The Board of Governors of the **Philadelphia Bar Association** voted to endorse "marriage equality" and called on the legislature to pass SB 719 or HB 1686 to legalize same-sex "marriage."

The media is blasting **Ambassador's Bible Chapel** in York County for issuing a letter of discipline, revoking the membership of and denying communion to a 20 year old man who has announced he is "gay." The church has made it very clear that he is welcome to continue attending church.

News from National Scene
The Congressional Budget Office is now estimating that **Obamacare** will reduce labor force compensation by 1 percent from 2017 to 2024, twice the reduction it previously had projected.

Four thousand homosexual and transgender activists attended the **Creating Change LGBT Conference** in Houston, TX from January 29th to February 2nd. Sponsors included Southwest Airlines, AARP, Comcast,

Hilton Worldwide, Office Depot, Planned Parenthood, Quaker Oats and Wells Fargo

CVS announced it will stop selling tobacco products to "help people on their path to better health." They will continue offering Plan B and other abortion causing drugs.
