News From Around PA

A 2-1 Commonwealth Court decision, will force an **Old Order Amish** family in Warren County to connect to the sewer system using electric equipment. Use of electricity is against their religious beliefs.

Philly-area Congressman Brendan Boyle (D-13) has introduced the "**Stable Genius Act**" specifically targeting President Trump's mental health.

In a split decision, a **three-judge panel** has tossed a lawsuit from a group of PA voters who want to have PA's current congressional map redrawn. A second lawsuit is still pending before the PA Supreme Court.

Havertown's St. James United Church of Christ will host an LGBT Couples Workshop next weekend.

Not to be confused with the Church of Christ, the United Church of Christ has supported so-called same-sex marriage for decades.

REAL ID compliant drivers' licenses will cost \$60.50 -- a one-time \$30 fee, plus a license renewal fee, which is currently \$30.50. Any time left on the old license will be transferred to the new one.
