News From Around PA
The Same-Sex Marriage
Equality Wedding Expo,
presented by the American
Bridal Show Company, will
be held January 25 the at
Pennsylvania Convention
Center in Philadelphia.

PSSA test development will remain in the hands of Data Recognition Corp. through 2015, despite the state Department of Education's plans to dissolve its standing contract with the vendor by the end of last year. Instead the contract was extended, at a cost of \$50 million, to align with Keystone Exams.

Easton Area School Board President Frank Pintabone, in his last year in office, has indicated he wants to start the meetings with prayer. His proposal was rejected by a 4-5 vote of the board. He said he will bring the matter up again next month.

State Reps Dan Frankel (D) and Chris Ross (R) are circulating a co-sponsorship memo to reintroduce the homosexual special rights bill HB 300. A bill has also been introduced to add "sexual orientation" to the PA hate crimes law.

News from National Scene
The Obama administration
said Thursday that faithbased nonprofits should
comply with Obamacare's

They said non-profits should
not expect the Hobby Lobby
case to bail them out.

The Respect for Marriage Act, which would repeal the Federal Defense of Marriage Act in its entirety, was introduced in both the US House and US Senate this week. PA Congressmen Matt Cartwright (D-17th) and Mike Doyle (D-14th) are cosponsors of the House version and Senator Bob Casey is a co-sponsor of the Senate version.

The **Connecticut Superior Court** has ruled that a 17 year old girl (she'll be 18 in nine month) who, along with her mother, tried to reject chemotherapy for Hodgkin's lymphoma can be forced to undergo the treatment.

The **Dept.** of **Homeland Security** has again extended
Temporary Protection Status
for more than 200,000 El
Salvadorans, currently living
in the US, citing damage
from an earthquake in that
country 14 years ago as the
justification.
