News From Around PA

Kate L. Blatt, the transgender "woman" who is suing the **Cabelas store in Hamburg, PA**, filed a legal challenge of the Americans with Disabilities Act's exclusion of gender-identity disorder as a protected disability -- contending that Congress acted unconstitutionally in 1989 when excluding GID as a protected disability under the ADA.

Philadelphia's Mural Arts Program organizes the wedding of a couple on the **Love Train**, in February. This year they are seeking a same-sex couple for the February 8th event.

Fifty people have donated \$7,745 so **Lancaster** can fight a lawsuit brought against it by the National Rifle

Association which opposes a local ordinance requiring residents who either lose a gun or have one stolen to notify police within 72 hours of learning of a missing gun.

News from National Scene

California's Supreme Court has voted to prohibit state judges from belonging to the **Boy Scouts of America** on grounds that the group discriminates against those who identify as homosexual.
