News From Around PA

"Kate Lynn" Blatt is a man who thinks he is a woman. In the past he caused a disturbance in a Philly KMart which resulted in all store employees having to receive sensitivity training to learn how to accommodate "transgender" customers. Now he is suing the **Cabela's in Hamburg, outside of Reading**, for disability discrimination because he suffers with "gender dysphoria." A December trial date is set. Damages of \$150,000 plus are sought.

Philadelphia City Council has unanimously passed a bill prohibiting parents from seeking counseling for their minor child with unwanted same-sex attraction. It now awaits the mayor's signature.

A massive outcry from pro-lifers has caused the **Reading**

School board to pull the proposal to allow Access Matters to open a "sexual health counseling center" inside Reading High School. Planned Parenthood was to oversee daily operations!

Allentown is also considering a bill that would make it illegal for parents to seek counseling for their minor child with unwanted same-sex attraction. It was introduced by open homosexual council member Candida Affa. The majority of council members and the mayor support it!

Over the objections of homosexual activists and their allies, **HB 1410 - the misnamed "Fairness Act"**-- was placed in the House State Government Committee chaired by Rep Daryl Metcalfe. This bill would add "sexual orientation and gender identity or expression" to the PA Human Relations Act and would unfairly target Christians who believe in the biblical definition of marriage

Third Circuit Court of Appeals denied **Harrisburg's request** to rehear the case brought by pro-lifers in their lawsuit

against Harrisburg's buffer zone ordinance. It amended its original opinion to clarify pro-lifers need only show harm by restrictions of their free speech, then the burden shifts to the city to justify its law.

Minersville Area School District has asked that the case brought by a third-grade "transgender" student be dismissed, citing the Trump Administration's guidance on LGBT students.

News from National Scene

Late Friday the **Pentagon issued a statement** delaying for six months former Defense Secretary Ashe Carter's July 1st deadline to allowing "transgenders" to enlist in the military. The service chiefs had asked for the delay. Army and Air Force had previously asked for a 2-yr delay.
