News from National Scene
In order to protest the FDA's
total ban on homosexual
men from donating blood,
the second annual National
Gay Blood Drive was held
recently. An "ally" of a
homosexual man steps in

and gives blood in his stead. Open homosexual State Rep Brian Sims says the ban is "based in fear and discrimination." Hmm, he must not have read the recent stories of people getting HIV from tainted blood and organs that were donated by "gay" men who did not tell the truth about their sexual preference.

Congressman Jackie Speier (D-CA) introduced *Military Separation Pay Fairness Act* which would provide the separation pay that was denied to homosexual servicemembers who were discharged under the Don't Ask, Don't Tell policy.

Oversight & Gov't Reform Chairman **Darrell Issa** (R-CA) has sent President Obama a letter calling for an end to the 2012 executive order granting stays of deportation to children brought into the country illegally by their parents.
