News From Around PA

U.S. District Judge Lawrence Stengel says the "ability of minor parties to organize and voice their views has been decimated" by portions of the state's election code.

Someone removed Erik **Arneson's** desk phone at the Office of Open Records. Later. he was told PennDOT human resources he was not being processed or getting a computer. A day after a Commonwealth Court majority opinion said he could go back to work as executive director of OOR, he found himself working out of the Senate. His lawyers, in a court filing, called it "obvious interference" Gov. Tom Wolf.

Katie McGinty stepped down as Gov. Wolf's chief of staff amidst rumors of a potential bid for US Senate. She is being replaced by Mary Isenhour, a board member of Planned Parenthood and the homosexual group Equality PA.

Speaker of the House Mike Turzai and Senate Pro-Tem Joe Scarnati have asked AG Kathleen Kane to investigate Planned Parenthood.

By a vote of 49-0, the Senate passed a bill that would postpone using the **Keystone Exams** as a graduation requirement until 2019.

News from National Scene

Senator Mike Lee and Rep.
Raul Labrador have introduced the First Amendment Defense Act (S. 1598, H.R. 2802) to safeguard "individuals and institutions who promote traditional marriage from government retaliation."

Since the US Supreme Court ruling on marriage, a new Rasmussen Reports national survey finds that 33% of Likely U.S. Voters now believe that states should have the right to ignore

federal court rulings if their elected officials agree with them. That's up nine points from a February survey.

Liberty Counsel is poised to file a lawsuit after the City of Somerset, KY, has arbitrarily mis-categorized a cross monument as a "sign" and denied Cross Ministries request for a building permit to erect the monument on private property next to U.S. Highway 27.

The 29-foot Mt. Soledad cross that overlooks the Pacific Ocean has been purchased from the DOD by the Mt. Soledad Memorial Association, the veterans group that maintains the memorial. This ends a 25 year legal battle by an atheist to get the cross removed. We are a non-profit organization that is totally dependent upon financial gifts from supporters.
