News From Around PA The PA Supreme Court has refused to reconsider the case brought by Philadelphia against its own public transit system -- **SEPTA**. The city argues that SEPTA must adhere to its LGBTQ-inclusive Fair Practices ordinance, while SEPTA argues that as a state agency it has "sovereign immunity" from complaints handled by the Philly Human Relations Commission. The high court agrees, bringing the almost ten year lawsuit to an end.

Two dozen Drexel University alumni gathered to discuss ways the newly formed **LGBTQA Alumni Network** could become involved on campus. The new network is simply an extension of Drexel's "affirmation and visibility of LGBT communities" at the school.

After last week's delay of a similar resolution in the **PA Senate**, the PA House passed, by a vote of 182-11, a resolution designating June a "LGBT Pride Month."

Upper Dublin Township (Montco) is considering a new ordinance which would extend special protections to homosexuals, bisexuals and transgenders and create a human relations commission to enforce it. Next township meeting is July 11th.

Governor Wolf has signed into law legislation that chips away at the **Keystone Exams** requirement. It would eliminate statutory the requirement for the development and implementation of Keystone Exams in English Composition, Algebra 11, Geometry, U.S. History, Chemistry, Civics and Government. and World History, and allow career and technical education students to meet their graduation without requirements demonstrating proficiency on the three currently implemented Keystone Exams (Algebra, Literature and Biology) if they complete grade-based requirements for the associated academic content area.

At the urging of Senator Bob Casey, the **US Dept. of Health and Human Services** has restored a question on sexual orientation in an assessment survey.
