News From Around PA

Did you know the attorney for **Vanessa Willock** is University of Pennsylvania law prof Tobias Barrington Wolff? Willock is the lesbian who successfully sued Elaine's Photography in New Mexico when they refused to photograph Willock's same sex commitment ceremony.

Philadelphia school district's grooming policy mandates beards on police and security officers be no longer than one-quarter of an inch. The U.S. DOJ sued the district for

religious discrimination for demanding that a Muslim police officer trim his beard.

In January 2012 a man applied for a job at the **Pittsburgh office of Maxim Healthcare Services Inc.** He was turned down for a VA hospital position because he is HIV Positive. The Equal Employment Opportunity Commission has filed suit against Maxim because of the applicant's rejection.

A recent tax sale of three condominiums in an **Erie medical building** erased the final traces of the abortion clinic operated there by Steven Brigham.

News from National Scene

The latest **Rasmussen Reports** national telephone survey finds that 61% of likely U.S. Voters oppose Obama's plan for the US to give up its last remaining control over the Internet.

Senators Mike Enzi (R-Wyo.), John Cornyn (R-Texas) and John Barrasso (R-Wyo.)

introduced S.J.Res. 34, which would allow states to repeal federal laws and regulations if ratified by two-thirds of state legislatures.

The **federal government** has increased its debt by \$811,699,611,000.51— borrowing \$7,057.89 per U.S. household—in the five months since the partial gov't shutdown ended.
