Pennsylvania's largest homosexual lobby group, Equality Pennsylvania, conjunction with the National Center for Equality, Transgender released the results of a 2015 US Transgender Survey. It is being used to push for passage of the homosexual special rights bill, the PA Fairness Act (HB 1410/SB 613) or, at a minimum, pushing for the PA Human Relations Commission change the definition of "sex" to "sex stereotyping" in the PA Human Relations Act.
