**News From Around PA**

Two Pittsburgh-area men, who have been in a homosexual relationship since the 1970s, **arranged for one to adopt the other** in 2012. Now they want to get "married" and a judge has told them he does not have the power to grant the adoption annulment they want. Senator Bob Casey wants the Dept. of Justice to "consider issuing guidance."

**State Rep. Dwight Evans** has announced he will challenge indicted Congressman Chaka Fattah next year.

Governor Tom Wolf signed a **labor intimidation bill** into law dealing a major blow to organized labor. Throughout the legislative process, most Democrats and a handful of union-backed Republican legislators had opposed it.

The **special state Senate committee** looking into whether AG Kathleen Kane can continue to function as Attorney General without a valid law license will hold its first public hearing on Nov. 9

**Guy Reschenthaler** defeated Democrat Heather Arnet in Tuesday's special election in the 37th Senate District. The victory gives Republicans a 31-19 majority in the Senate -the largest in 60 years.

**News from National Scene**

Rep. Lamar Smith, chairman of the **House Committee on Space, Science and Technology**, has written to Professor Jagadish Shukla of George Mason University requesting that he release all relevant documents pertaining to his activities as head of a non-profit organization called the Institute of Global Environment And Society. Shukla has called for the imprisonment of "global warming" skeptics and Smith is concerned about the "partisan political activity" of this organization and also wants to know how the \$63 million in taxpayer grants has been spent.

Ten **Obamacare** co-ops have collapsed this year. They had received more than \$1 billion from the government. Five of those—in CO, NY, KY, SC, and UT—attributed their decision to close because of the risk corridor payments. The Obama Administration had announced two weeks ago that providers would receive just 12.6 percent of their requested amount.
