News from National Scene Dr. Graham Chelius, an obgyn and abortion activist in Waimea, Hawaii, is suing the FDA and the U.S. Department of Health and Human Services with the help of the ACLU. The case seeks to force the FDA to allow pharmacies to give out the abortion drug mifeprex, also known as mifepristone or RU-486. Currently a longstanding FDA regulation only allows this abortion pill to be dispensed at a medical facility under the care of a certified provider.

Attorney General Jeff Sessions has issued a memo to U.S. Attorneys' offices saying Title VII of the Civil Rights Act of 1964 only prohibits discrimination on the basis of a worker's biological sex, and not their gender identity.
