News From Around PA

Bad idea! **Sen. Anthony Williams** (D-Philadelphia) has proposed to create an appointed commission that would select judicial candidates. Under the bill, the governor would make a nomination out of that group and the state Senate would confirm.

FDA has approved **Shippensburg University's** Plan B dispensing vending machines. Students at the university can obtain Plan B without waiting for an appointment by depositing \$25 in the machine. The machine is located near others which sell condoms and pregnancy tests.

Haverford Township supervisors (Delaware County) will be voting on February 11th for applicants to fill a seven-member human-relations panel "to investigate antibias complaints, and allows for penalties of up to \$5,000 per discriminatory act." i.e. bakers who don't want to bake cakes for same-sex "marriages" and those who complain about a man in the women's restroom or shower at the local Y.

Homosexual group **Human Rights Campaign** has formed a coalition to support the repeal of the federal Defense of Marriage Act. Members include eBay, Marriot International, Bristol-Myers Squibb, Aetna, Mass Mutual Life Insurance, Kimpton Hotel and Restaurant Group, Sun Life Financial Inc., Thomson Reuters Corp., Giorgio Armani SpA and Biogen Idec Inc.
