Filters on school computers:

this from the PA DOE - "We verified that the Children's Internet Protection Act ("CIPA") is still good law and is codified 20 U.S.C. 6801, 6777, 9134. CIPA was upheld by the U.S. Supreme

Court in 2003 because it does not violate the first amendment's free speech clause. U.S. v. American Library Ass'n, Inc., 539 U.S. 194 (2003). Essentially, CIPA requires that elementary and secondary schools and libraries that receive certain federal (E-rate) funding must have internet filters and other measures to protect children from harmful online content. The condition of receipt of these funds also requires that the school or library receive a discounted rate of internet service from a carrier pursuant to 47 U.S.C. 254(h)(1)(B)." Is your child safe from porn at their school library?

New from National Scene

CLASS Act has lost its class! On Feb. 1st US House voted to repeal this provision of Obamacare which set up a home-care program for elderly/disabled. Regulators said it was unworkable.

HR 3828 - Military Religious Freedom Protection Act was recently introduced by Congressman Tim Huelskamp (R-Kansas). It says that "a service member cannot be denied promotion or other training opportunities for

any sincerely held beliefs he has about the appropriate or inappropriate expression of human sexuality." The bill also seeks to keep military property from being used to perform same-sex "marriage

Veterans Administration

was sued on February 1st. The federal lawsuit challenges the VA for refusing to recognize 'legally married' gay and lesbian couples and denying them the same 'family benefits' as their heterosexual colleagues. The lawsuit challenges the Defense of Marriage Act. NOTE: remember the ultimate goal of homosexual activists is the legalization of same-sex "marriage."
