### **News From Around PA**

#### **Philly vs. Boy Scouts Update-**

A three-judge panel of the 3rd Circuit Court of Appeals has granted the city's request to extend the deadline for filing its opening brief in its appeal to evict the Cradle of Liberty Scout Counsel from its headquarters. It has been extended to November 19.

#### **Philadelphia lesbian**

**magazine** attacks the Philadelphia Wax Museum for coming to the defense of Chick-fil-A. It is asking for a boycott of the museum and for sponsors to withdraw their funding.

### **News from National Scene**

**A survey conducted** by a coalition of religious organizations shows that the

number of mosques in the United States has grown by 74 percent in the past 11 years – up from 1,209 in 2001 to 2,106 in 2011.

#### **Executives from leading Washington state businesses**

are throwing their money behind the effort to pass same-sex-marriage legislation in that state. These include Costco, Nordstrom, Microsoft, REI, and Amazon. In some cases, emailing employees telling them how to vote on the issue!

#### **Hobby Lobby update:**

The US Department of Justice is urging a federal judge to deny a request by Hobby Lobby Stores to block enforcement of Obamacare.

#### **Two New York lesbians**

filed a complaint with the Division of Human Rights Oct. 11 after the Liberty Ridge Farm said it would not host their "wedding" next summer. The owners say their objections are based on their values and religious background. Supposedly there is "religious freedom" language in the new law.

#### **After the Obama**

**Administration** submitted legal papers asking a judge to strike down the Arizona law allowing the state to stop taxpayer funding of the Planned Parenthood abortion business, a federal judge blocked the law.

#### **Census data**
