I was elected in 2011 and successfully retained in 2021 to the Chester County Court of Common Pleas. In addition, I was elected to serve as President Judge, by my peers, in January 2025.

9.) Either as a judge or, if you are not currently a judge, as an attorney, please name two prominent cases you have been involved in – please include a brief description of the case.

a) CW v David Desper - road rage murder case that garnered national media attention. He pleaded guilty to 3rd degree Murder rather than stand trial for first degree. Sentencing hearing was covered by all Philadelphia media stations. I imposed the maximum sentence of 20-40 years.

b) CW v Clayton Carter - case involving an ongoing dispute between neighbors. Defendant shot Jennings, his neighbor, twice in the face during an argument they had while standing at the line that separated their properties. Defendant claimed he shot Jennings in self defense after Jennings encroached over the line on to Defendant's property and pulled a knife lunging at him. Expert testimony revealed the knife had Defendant's DNA, not Jenning's DNA. A "Ring" camera on a home a block over, recorded audio of the incident. The time between the first gunshot and the second is chilling and did not support Defendant's version of events and his claim of selfdefense. Jury convicted Defendant of first-degree murder and tampering with evidence. At sentencing, I sentenced him to the mandatory life sentence.

In both cases there were appeals to Superior Court. I was affirmed on both cases.
