News From Around PA

Erie City School Board President, **Tyler Titus, was recently spotlighted by the Victory Fund**, which helps fund campaigns for LGBTQ candidates. Titus, who is a transgender male (biological female) uses the “preferred pronoun” ‘they,’ is running for Erie County Executive. The Victory Fund notes if Tyler wins, he will “be the highest-serving queer, nonbinary elected official in Pennsylvania history.”

Victory Fund also backs Alexander Reber for Millersburg Boro Tax Collector; Sean Strub for mayor of Milford and Gregory Yorgey-Girdy for Philadelphia Municipal Court.

Chambersburg Boro in Franklin County is the next target of LGBTQ activists who want a so-called anti-discrimination ordinance with sexual orientation and gender identity language passed.

Another **Drag Queen Bingo** will be held at the Zem Zem Shrine Club in Erie in May 2.

News From National Scene

Chief Justice John Roberts was the lone dissenting voice in the free speech case involving two former Georgia Gwinnett College students **who sought to exercise their religious liberty on campus.** After obtaining the appropriate permit as required by the school, the students sought to share their faith by handing out tracts in the school’s “free speech zone.” However, other students complained and the Christians were stopped by campus police saying their speech “disturb(ed) the peace and/or comfort” of others.

Transgender powerlifter JayCee Cooper is suing USA Powerlifting for being barred from competition. The lawsuit was filed in MN by Gender Justice. They assert

that banning Cooper and other trans athletes violates the MN Human Rights Act.

The Army announced that it will keep the events on the third version of the Combat Fitness Test gender-neutral, but male and female soldiers will be evaluated on separate gender-specific percentile tiers, amid concerns female soldiers are scoring lower and disproportionately failing the test compared to their male counterparts.

Hundreds of corporations and celebrities have signed a statement saying **they oppose “any discriminatory legislation” that makes it more difficult for people to vote.** These include Amazon, Apple, American Airlines, Bank of America, Facebook, Netflix, Target, Twitter.
