News from Around PA

The Congressional Progressive Caucus wants to codify the “right” to trans surgeries, puberty blockers and cross-sex hormones for minors. PA members of this caucus are: Chris Deluzio (D-17), Summer Lee (D-12), Brendan Boyle (D-2), Matt Cartwright (D-8), Madeleine Dean (D-4), Dwight Evans (D-3), Mary Gay Scanlon (D-5).

Penn State’s Center for Sexual and Gender Diversity is helping sponsor the school’s “Campus Pride Month” which runs throughout April. Penn State campuses will participate in events such as drag queen bingo, “Karao-Gay,” which is an “LGBTQ+ inspired karaoke”, “GaySL: A course in LGBTQ American Sign Language and Intersectionality.

Campus Pride, which is the “National Listing of LGBTQ-Friendly Colleges and Universities,” gave the school its maximum score of five stars in its “Campus Pride Index” in 2023.

State House Democrats voted to allow one of their members, **Kevin Boyle (D-Philly)**, to vote remotely even though he was absent from the chamber and being sought by police for violating a protection from abuse order. House Speaker Joanna McCClinton, (D-Philly), said that Boyle had filed the paperwork to allow Democratic leaders to vote on his behalf and that the lawmaker had not taken any steps to revoke that designation.

News From National Scene

British pediatrician **Dr. Hilary Cass** released a new study which confirms that children who suffer with sudden onset gender dysphoria are actually suffering from other mental health diagnoses—not true gender dysphoria. This debunks the idea that “gender-affirming care” (puberty blockers, cross-sex hormones, surgery) must begin immediately. Cass’ research instead reveals that children who think they are trans disproportionately have mental health issues stemming from a difficult family situation or abuse.

Kansas Governor Laura Kelly vetoed a bill that would have

protected minors from so-called gender-affirming care. Yet another Democrat pushing the LGBTQ agenda!

The **Pregnant Workers Fairness Act** was passed several years ago to help pregnant workers in the workforce. Employers were instructed to accommodate doctors’ appointments, offer temporary reassignments to less physically taxing jobs, or provide chairs so a pregnant woman didn’t have to stand on her feet all day. However, the Biden Administration just issued a new rule that says employers must also accommodate abortions under this law!!

Greg Garrett, a self-described pro-choice, gay/trans-affirming Baylor University professor, says the 200-year old hymn, “Brethren We Have Met to Worship,” is sexist.
