The Board of Directors of the Oil City Area School District (Venango County) voted to suspend both *We Care* and *Sexual Abuse Free Environment for Teens (SAFE-T)* sexual abuse training for the rest of the school year. Parents had objected to the curriculum due to its indoctrination and also complained about the lack of transparency from the school, the board and administration. This curriculum is recommended by the PA Dept. of Education!

PA State Senator Ryan Aument has reintroduced legislation that would allow parents to block schools from giving their children access to materials the parents deem sexually inappropriate. Under SB 7, schools would be required to identify all materials that contain sexually-explicit content, offer parents the opportunity to review those materials and get the parents to sign off on their children's access to it.

Governor Josh Shapiro says he will dismiss any calls for Senator John Fetterman to step down after he checked himself into Walter Reed Hospital in order to be treated for clinical depression.

Wisconsin **Republicans used a procedural move to freeze**, through 2024, any future attempts by Governor Tony Ever's Administration from enacting a ban on talk therapy for minors with unwanted same-sex attraction and gender confusion.

Loudon County, VA schools allows teachers to use preferred pronouns or phrases in email signature blocks that express the teacher's personal views on various subjects. One teacher included the citation John 3:16 (not the verse) and school officials immediately ordered her to cease and desist because she was establishing a religion!

Democrats in the US House and US Senate have introduced the **International Human Rights Defense Act**. It would "make permanent the office of Special Envoy for

the Human Rights of LGBTQI+ Persons which President Biden established early in his term, as well as ensure that future administrations continue to uphold LGBTQI+ rights on the world stage by directing the State Department to document and respond to bias-motivated violence against LGBTQI+ people abroad and implement a comprehensive strategy to prevent and respond to criminalization, discrimination, and violence against LGBTQI+ people."
