The Northern York County School District has voted down the formation of an After School Satan Club. Several districts in the county with а Christian work organization to offer offcampus religious instruction during the school day. PA law allows 30 minutes of offcampus religious instruction each week called Release Time. The mother of elementary students claimed her children were missing out on after school activities due to a lack of secular options and proposed the Satan Club. The other Republican, Nichole Missino, was also removed from the ballot, even though the objection to her nomination paper was not filed properly. So, there will either be a GOP write-in campaign on May 17<sup>th</sup> or the incumbent Democrat will run unopposed in the fall.

Alabama Governor Kay Ivey signed HB 322 into law. It will require K-12 students to use the bathroom aligned with their biological sex. It also prevents K-5 students from being targeted for LGBTQ indoctrination.

In response to the US Dept. of Health and Human Services guidance on treating gender dysphoric children and adolescents, the Florida Dept. of Health issued its own guidance to clarify evidence. This included "social gender transition should not be a treatment option for children or adolescents; anyone under 18 should not be prescribed puberty blockers or hormone therapy; gender reassignment surgery should not be a treatment option for children and adolescents; children and adolescents should be provided social support by peers and family and seek counseling from a licensed provider".
