#### **News From Around PA**

**A nonbinding motion denouncing state and federal attempts** to pass bills that ban males from participating in female sports was written by two Allegheny County Council Democrats. The motion failed in the Democrat-controlled council by a 7 to 6 vote, failing to reach the necessary 8 votes.

The **Philadelphia 76ers** will hold its annual Pride Night on April 26<sup>th</sup> when the 76ers host the Oklahoma City Thunder.

**Open homosexual Dr. Kevin Baumlin**, chief of emergency and urgent care services at Pennsylvania Hospital, has announced his candidacy for US Senator. He joins seven others as he enters the Democratic primary race.

A former employee of **Northeast Building Products** is suing the company for discrimination claiming she lost her job because of the fact she is black and lesbian.

She is seeking an undisclosed amount in compensatory and punitive damages, an LGBT-inclusive antibias policy and training for all employees.

**Olivia Rondeau**, a female college wrestler at East Stroudsburg University and a repeat National Champion in high school, has made a video denouncing attempts to pass laws allowing “transgender females” (biological males) to compete in female sports.

The **US Supreme Court** declined to hear a lawsuit regarding PA’s mail-in ballots which was brought by congressional candidate Jim Bognet. The lawsuit challenged the PA Supreme Court’s authority to extend by three days the time in which mail-in ballots could be received. This is the final November 3-related action to be dismissed related to PA.

#### **News From National Scene**

HHS Secretary **Xavier Becerra** has sued in an attempt to overturn a recent court ruling against the mandate that forces doctors and hospitals to perform transgender surgeries, regardless of religious or conscientious objections.

A **former Virginia Tech soccer player** is suing her former coach after she was forced off the team for refusing to kneel during the reading of a ‘unity statement’ in a pregame social justice/ BLM demonstration.

**North Dakota Governor Doug Burgum (R)** has joined South Dakota Governor Kristi Noem (R) in vetoing a bill that would have protected girls’ sports by banning biological males from competing on female sports. He says the North Dakota High School Activities Association, which opposed the bill, already has rules in place that protect girls’ sports by allowing biological males who identify as female to compete against females upon “completing one calendar year of documented testosterone-suppression treatment.”
