A group of **State House Democrats** are proposing **legislation** that would call for a study on the impact the aggressive marketing of sports betting during broadcasts of sporting events may have on problem gambling. So, they are going to spend our taxpayer dollars to study a problem they were warned was going to happen before they legalized sports betting!

Allegheny County **Democrat La'Tasha Mayes** has introduced legislation that would direct the state Department of Health to develop a program to provide new moms with kits of supplies needed to begin taking care of their new babies. And this after Governor Josh Shapiro ended the funding of Real Alternatives, which helped pregnancy centers offer diapers and other baby needs to new moms.

Trans Minors Rights, located in Lancaster, is circulating a petition of convince the General Assembly to pass a

law that would allow 14-year-olds to get puberty blockers without parental consent.

News From National Scene

LGBTQ+ and “allied” members of Congress have introduced a resolution to support the **Rise Up for LGBTQ+ Youth in Schools Initiative**. The resolution is “to demand equal educational opportunity, basic civil rights protections, and freedom from erasure for all students, particularly LGBTQ+ young people, in K–12 schools”. Interpretation: they want boys who identify as girls in the girls’ bathroom, locker and shower room, and on their sports teams. PA members of the Congressional Equality Caucus are Mary Gay Scanlon (PA-5), Brendan Boyle (PA-2), Matt Cartwright (PA-8), Madeleine Dean (PA-4), Chris Deluzio (PA-17), Dwight Evans (PA-3), Chrissy Houlahan (PA-6), Summer Lee (PA-12), Susan Wild (PA-7).

The **Borderline Dance Squad** was set to perform at the Emerald City Hoedown in Seattle, WA. However, their American flag themed shirts made some people in the audience feel “triggered and

unsafe” and they were booted from the competition.

The **Medical Director of the Gender Health Program** at the Minnesota Children’s Hospital, a nonbinary doctor, claims pronouns affect children’s mental health, thus you must never “misgender a transgender” child.

The Fourth Circuit Court of Appeals ruled West Virginia’s new **Save Women’s Sports Act** does not apply to a 13-year-old middle school boy who has lived as a girl for over five years. Two days after the decision, he won the shot-put competition by three feet. Five female students stepped out in protest of the boy’s participation. They have been barred from competing in the event at the next meet. The students have sued and the WV Attorney General says he will appeal the 4th Circuit decision.
