News From National Scene

Texas, Oklahoma and Iowa **stop abortions** during the COVID-19 pandemic!

Dr. Rodney Howard-Brown was adhering to the law, obeying an emergency order and following the recommendations of the sheriff who gave him approval to meet when he was arrested without warning and jailed!

The Idaho governor has **signed two bills into law** - one would ban males who think they are females from playing in the sports that align with who they think they are and the other would make it illegal for transgender to change the sex on their birth certificates.

Nevada governor Steve Sisolak has issued an emergency order banning doctors from prescribing anti-malaria drugs chloroquine and hydroxychloroquine to coronavirus patients.

An unprecedented dip in the **U.S. blood supply** has led the FDA to relax long-standing restrictions on receiving blood donations from sexually active homosexual men. Previous federal rules

required that donors wait 12 months from their last homosexual intercourse before giving blood. Now, that wait has been shortened to three months. The policy also applies to women who have had sex with gay or bisexual men and those who have received tattoos or piercings, each of which have also had wait times reduced from twelve months to three. LGBTQ activists are still not happy saying any restrictions on blood donation from homosexuals place an undue stigma on gay people.

Utah Governor Gary Herbert has signed a bill **placing a ban on most abortions**, which will be automatically be "triggered" once *Roe v. Wade* is overturned or otherwise negated, as well as a law to ensure that the remains of babies killed in abortions be treated humanely.
