News from Around PA

Good Bill: SB 471 would require prosecutors to notify U.S. Immigration and Customs Enforcement when a criminal defendant is identified as unlawfully present in the United States. It passed in the State Senate by a vote of 31-18.

TransYOUning rallied outside UPMC Hamot in Erie to protest the hospital system's "outrageous decision to begin denying full gender-affirming medical healthcare for new and some existing patients under 19 years old" at UPMC's Children's Hospital of Pittsburgh. Tyler Titus, an Erie City Council member and "transgender man" (biological female), said they were "denying science and the decision was rooted in fear".

It's official. Pittsburgh now has a **chapter of the Communist Party**. Appearing in a group picture are Bethany Hallam (Democrat at Large County Councilwoman), Sara Innamorato (County Executive), and Summer Lee (Congresswoman).

State Senate approved a bill that would limit how long **acting secretaries** can lead state agencies without getting Senate confirmation. This is needed to

counter efforts to circumvent Senate oversight and "pointed to the practices of former Gov. Tom Wolf." Wolf repeatedly named acting secretaries, who remained in their posts for months, without being formally nominated, go through confirmation hearings and voted on by the Senate.

News From National Scene

DOGE has discovered that the **Small Business Administration** has approved \$330 million worth of loans to people under the age of 11!

Idaho Governor Brad Little signed legislation requiring middle and high school students to be taught about fetal development.

Kentucky legislators protected taxpayers from funding sex change procedures after they overrode liberal Gov. Andy Beshear's veto.

The **Nevada Interscholastic Activities Association**, which governs high school sports, approved a new policy protecting women's sports from biological males.

The **Alaska State Medical Board** formally asked the legislature to protect children from so-called "gender-affirming care", saying such radical procedures "lack legitimacy" due to "insufficient evidence of long-term benefits and risks of irreversible harm."

Colorado House Bill 25-1312, cynically titled the "**Kelly Loving Act**," would categorize a parent calling their daughter "she" or 'deadnaming' their child as forms of child abuse. This bill weaponizes family courts and redefines "coercive control" to include not letting your 12-year-old son wear lipstick and call himself Ashley.

Women's fencer Stephanie Turner was to fence in the Cherry Blossom Open in Maryland, instead she took a knee refusing to compete against a "transgender female". Turner was immediately expelled from the competition.
