**News From Around PA**

PA has publicly admitted that a supposed glitch in PennDOT's programming has **allowed foreign nationals to register to vote for decades!** The US District Court for the Middle District of PA sided with the Public Interest Legal Foundation and said PA must allow the inspection of records showing the extend of the problem and actions taken by PA to rectify errors in the official voter lists! Eleven hundred non-citizen registrants self-reported their ineligibility and requested the cancellation of their voter registrations.

A whistleblower educator has revealed that **Great Valley School District's** (Chester County) transgender policy prevents teachers from telling parents if their child is questioning his or her gender identity! Additionally, the teacher must call the gender-confused child by the name they choose and refer to them by the "correct" pronouns.

The Faith-based Organization Coalition is being formed under the **PA Dept. of Health**

and is expected to launch on April 11<sup>th</sup>. Its mission is to "harness the power of community trust in statewide faith-based organizations." The "Local Innovations in Vaccine Equity in PA" project will pay churches to persuade their members to get the COVID shot!

The Nominating Petition of **open homosexual US Senate candidate** Kevin Baumlin were challenged and he has withdrawn from the race.

Rob Jordan is listed as a leader of the national **Log Cabin Republicans!** That is a faction of the GOP that pushes the LGBTQ agenda. He is also a candidate for State Rep in the 165<sup>th</sup> District (Delco). His Nominating Petition is being challenged as it appears he lived in Philly until early this year. According to the PA Constitution, he must live within the district he is running in for one year.

#### News From National Scene

A female black pastor, who had just been appointed to **New York City Mayor Eric Adams education policy panel**, was recently removed when it was "discovered" she had written a book that called homosexuality a sin.

West Virginia and Kentucky have just passed laws that **prohibit local and state election officials from accepting certain gifts** and other funds from nongovernmental entities to conduct elections i.e. money from Facebook's Mark Zuckerberg Center for Technology and Civic Life (CTCL). Remember at least 21 PA counties received \$22 million from CTCL in the fall of 2020. SB 982 has been introduced to prevent such money from flowing into PA in the future.

A TX woman has won a \$90,000 settlement from her former high school after she claimed teachers harassed her for not standing for the **Pledge of Allegiance**. She took offense to "under God" and "liberty and justice for all". Attorneys with American Atheists handled the case.
