#### **News From Around PA**

Embattled **State Senator Daylin Leach** will have at least three Democrat challengers in next year's primary.

**Women in Medicine** held its 26<sup>th</sup> annual conference in Philly this week bringing together women and sexual minority physicians and medical students who identify as LGBTQ.

To combat the **opioid crisis**, LGBTQ and HIV/AIDS organizations are working to bring a medically-supervised "consumption site" into Philly's Kensington section.

**TD Bank Young Heroes Awards** will be held August 15 at the National Liberty Museum in Philly. The Keynote speaker is KC Miller, founder of the Keystone Coalition for Advancing Sex Education, which seeks to mandate comprehensive sex ed in PA and beyond!

The **LGBTQ-plus 2020 Census Philly Complete Count** Sub-Committee is educating on how to "navigate the barriers to an inclusive count."

#### **News From National Scene**

The MN Dept. of Human Rights has been given the green light to join a lawsuit against **Anoka-Hennipin School District**. The district is being sued because they required a "transgender boy" (a biological girl) to change in an "enhanced privacy" boys' locker room which was separate from the main boys' locker room. The state, the student and parents are claiming discrimination.

A federal **heartbeat bill** (HR 3985) has been introduced by US Rep. Bill Flores (R-TX) and US Rep. Debbie Lesko (R-AZ).

North Carolina's Democrat Governor Roy Cooper and some progressive politicians have settled with **transgender activists** and the state will now allow gender confused individuals to use the bathroom which corresponds with this preferred gender. The settlement completely ignored existing law and left out the entire legislature!

New federal rules under the Trump administration prohibit giving **Title 10 dollars** to health providers that refer for abortion. So, given the choice of taking the federal dollars or giving up its abortion business, Planned Parenthood chose abortion.

Before the school year starts for the **Racine Unified School District**, counselors and social workers at the elementary school level are scheduled to receive "safe zone" training from the Racine-based LGBT Center of SE Wisconsin.

President Trump's nominee to the **U.S. District Court for the Northern District of Illinois** has been confirmed by voice vote. She is a lesbian who is "married" to a woman, a member of the Lesbian & Gay Bar Association of Chicago and Lambda Legal **Defense and Education Fund!**
