Pennsylvania Psychiatric Institute is a facility affiliated with Pennsylvania State University. They are partnering with **Vote-ER** to register patients to vote!! Vote-ER was founded by an ER physician at Harvard Medical School, Alister Martin, who served as an advisor to VP Kamala Harris. Doctors have used Vote-ER tools to also register voters in cancer centers, emergency rooms, substance abuse centers, palliative care centers and the parents of newborns in NICUs, including the Children's Hospital of Philadelphia! From their info sheet: "Since 2020, Einstein Healthcare, Penn Medicine, and Children's Hospital of Philadelphia have forged a strong alliance with Vote-ER. They seamlessly integrate Vote-ER materials into their waiting rooms and discharge paperwork, and staff wear Vote-ER badges & lanyards."

A co-sponsorship memo is being circulated by **State Rep Ryan Warner** (R-Fayette) for a bill that would require proof

of citizenship in order to register to vote.

Many **PA businesses have announced their support** for adding sexual orientation and gender identity or expression to the PA Human Relations Act. Here are a few: Giant Eagle, Hershey, UPMC, The Giant Company, Erie Insurance, Highmark Health, Geisinger, Harley Davidson, PNC, WAWA. Remember this impacts employment, housing and public accommodations. For one thing, this means opening women's private facilities to men who identify as women.

Delta's Chief Diversity, Equity, Inclusion & Social Impact Officer Kyra Lynn Johnson has said publicly Delta is continuing to "boldly pursue equity." "So, we're beginning to take a hard look at things like our gatehouse announcements. You know, we welcome 'ladies and gentlemen.' And we've asked ourselves, 'Is that as gender inclusive as we want to be?'"

Books by Margaret Atwood, Judy Blume, Rupi Kaur and Sarah J Maas are **among 13 titles that the state of Utah has ordered to be removed**

from all public school classrooms and libraries because of their age inappropriate sexual content.

Planned Parenthood has nearly 600 clinics nationwide making it the largest single provider of abortion. Some who were given these hormones after a minimal amount of "counseling" are suing Planned Parenthood.
