Allentown will soon consider an ordinance that will label **pregnancy centers as purveyors of misinformation** deserving of heavy scrutiny, places anti-free speech buffer zones around abortion facilities, and deprioritizes law enforcement from investigating abortion-related crimes.

Since 2018 the **Gender Awareness and Inclusion Network (GAIN)** has worked primarily in the Lower Merion School District (Montco) pushing for “gender inclusion.” It has organized an LGBTQ+ inclusive sex ed talk for elementary students. GAIN leadership plans to branch out and fight for trans and nonbinary youth via advocacy, collaboration and community outreach.

News From National Scene

The **American Federation of Teachers** promoted the use of a pronoun card which included a question of whether the student wanted their parents to know about their pronouns.

The **AP Style Book**, a go-to manual for journalistic grammar and style at most media outlets, says saying pregnant “women” is now offensive. It goes on to say, “A person’s sex and gender are usually assigned at birth by parents or attendants and can turn out to be inaccurate”. Of course, even using the phrase “biological” males would be a no-no.

San Bernardino County Board of Supervisors has voted unanimously to include on the November ballot a measure to secede from California

Jaelene Daniels, a defender for the **North Carolina Courage team**, chose to sit out during a recent National Women’s Soccer League game rather than don the “Pride” jersey her team was scheduled to wear.

Disney has signed a letter in support of HR 8404, which would codify the 2015 US Supreme Court decision which forced so-called “gay marriage” on the nation.

The **Fargo, ND School Board**, in a 7-2 vote, voted against reciting the Pledge of Allegiance before meetings, saying the phrase “under God” was not diverse enough and the pledge was divisive.

Transgender activist Eli Erlick has been working to distribute excess prescribed hormones for free to those who don’t have access to them, according to a since-deleted Instagram post that has been shared on Twitter.

District Judge Robert C. Chambers ruled that **West Virginia Medicaid** must provide coverage for gender reassignment surgery.
