News from Around PA

Chair of the **Lehigh County Human Relations Commission**, Liz Bradbury, traveled to Luzerne County to make the case for that county's recently passed anti-discrimination ordinance which includes "sexual orientation and gender identity" language. Bradbury is an LGBTQ+ activist and co-founder of the Bradbury-Sullivan LGBT Community Center in Allentown! The Sullivan part of that name is Bradbury's partner and fellow LGBTQ+ activist.

LGBTQ activists are very concerned that **former State Representative Seth Grove's** appointment to the PA Human Relations Commission (PHRC) will create a roadblock to further their agenda! In their words, "He has along history of anti-LGBTQ+ actions" while he served in the General Assembly. Sounds like just the guy we need on the PHRC!

LGBTQ+ activists are still pursuing members of the **Municipality of Monroeville** council concerning the

removal of a "Pride" display in the children's section of the Monroeville Public Library the end of June. The activists claim, and text messages obtained from a Right to Know request, indicate pressure was placed on the library to remove the display.

News from National Scene

The full U.S. Eleventh Circuit Court of Appeals sitting *en banc* ruled 8-5 that Florida's **Protection of Children Act** was constitutional. This law bans the admittance of minors to "adult live performances" including drag queen story hours.

U.S. District Judge Emily Marks ruled the **Southern Poverty Law Center** (SPLC) did not meet the bar to demonstrate the Justice Department was motivated by animus in bringing the case, thus would not toss it out. In April a federal grand jury in Alabama indicted the SPLC on six counts of wire fraud, four counts of making false statements to a federally insured bank, and one count of conspiracy to commit concealment money laundering.

A father is suing the **Cabarrus County School District** in

North Carolina, saying parents should be told if their children could share restrooms or locker rooms with students of the opposite sex. The suit says school leaders denied his request for that information, citing student privacy.

A new report from the **Department of Health and Human Services**, "Wolves in White Coats: How Doctors and Hospitals Pushed and Profited from the Fraud of 'Gender Medicine,'" details the financial incentives behind the rapid expansion of "gender affirming care" for minors, including nearly \$120 million in billed charges for thousands of surgical and hormonal interventions between 2019 and 2023.

New York City's **Judson Memorial "Church"** recently invited people to find "queer liberation through drag".
