**News from Around PA**

Democratic attorneys general sued the Trump administration over its efforts **to stop gender-transition drugs and surgery for youth**, accusing the federal government of infringing on states' rights and denying patients "medically necessary health care." PA Governor **Josh Shapiro** joined the lawsuit, as PA Attorney General Dave Sunday is a Republican.

**Governor Josh Shapiro** has also signed onto a lawsuit against HHS Secretary Robert F. Kennedy, Jr. and Dr. Mehmet Oz, administrator of the Centers for Medicare and Medicaid Services. The lawsuit alleges the federal government is illegally blocking Medicaid funds from going to Planned Parenthood and affiliated "healthcare" providers. Attorneys General in 21 other states and Washington DC are bringing the lawsuit. All signatories are Democrats or working in Democrat-led

offices. Shapiro is the only signatory serving as governor, or outside of an attorney general's office.

**Emil Bove**, currently in the number three position at the US Department of Justice, was confirmed by a vote of 50-49 to serve on the Third Circuit Court of Appeals. This court covers Delaware, New Jersey, Pennsylvania and the Virgin Islands.

A "transgender male" (biological female) is suing the **Montgomery County Correctional Facility**, located in Eagleville, alleging her constitutional rights had been violated. She was housed with the female inmates over her protests. The lawsuit alleges she was "misgendered" by staff, given female undergarments and denied hormone therapy. She is seeking more than \$150,000 in compensatory and punitive damages along with the implementation of LGBTQ+ sensitivity training for jail workers.

#### **News from National Scene**

Randi Weingarten, president of the **American Federation of Teachers** announced a partnership with the globalist World Economic Forum to

craft a new curriculum for America's schools.

The Republican controlled **North Carolina House and Senate** overrode the veto of Democrat Governor Josh Stein. The bill will, among other things, define male and female based on biological sex in state statutes, rules and regulations; prohibit the use of taxpayer dollars for "gender-affirming care" and prevent the unlawful publishing of pornographic content on the internet.

Gay "pride" month is over, so the nation's largest LGBTQ lobby group, the **Human Rights Campaign**, is calling for a "Pride Victims Tour" which will target conservative states. Their main talking point is the claim they are "victims" of bigotry and hate, and they are going "to where the harm is happening."
