News from Around PA

Children's Hospital of Pittsburgh is now putting out promotional videos on puberty blockers for kids.

Philly residents have filed a lawsuit against the city and for donating half a million in tax dollars to **Abortion Liberation Fund of Pennsylvania**. PA law says, "no Commonwealth funds and no Federal funds which are appropriated by the Commonwealth shall be expended by any State or local government agency for the performance of abortion."

Governor Wolf has signed an executive order **prohibiting conversion therapy** for minors. This will prevent children with unwanted same-sex attraction or gender confusion from getting help.

The **National LGBTQ Force Action Fund** will continue to drive "Queer the Vote" to educate and mobilize LGBTQ+ rights supporters during key election cycles.

News From National Scene

Fourth Circuit Court of Appeals has ruled that the **Americans with Disabilities Act** covers people with "gender dysphoria". However, the ADA has an explicit exclusion of "gender identity disorders not resulting from physical impairments" from protection under the law!

Biden Administration had to back down from forcing private religious schools from abiding by new **Title IX rules** re boys who identify as girls playing girls' sports and using their facilities. The threat: comply or not be permitted to participate in the Federal Meal Program.

Kentucky Supreme Court upholds appellate court decision and will allow their abortion ban to go into effect. In November a hearing will be held on the lawsuit brought by Planned Parenthood and the ACLU as they seek to permanently block the law.

Voters in Jamestown Township, southwest of Grand Rapids, MI, **refused to approve an annual millage renewal for 2023 for the local library**. The library will lose 84% of its annual

\$245,000 budget because it refused to listen to parents' concerns about sexually explicit LGBT books such as "Gender Queer: A Memoir".

All Massachusetts **public universities and colleges** must now provide medical abortion either through their school's health services or local resources. They will be given a state grant to cover the costs.

In a YouTube video, Stacy DeCorsey, principal of **Excelsior Elementary School in Excelsior, Minnesota**, suggested kindergarten through second grade students read "Jack (Not Jackie)," a story about a young girl who begins to identify as a boy. An uproar followed and she has issued an apology via Facebook and deleted the original video. However, the book is still in the school's media center!
