News From Around PA

State Rep. Malcolm Kenyatta, the **first Black gay state legislator in PA**, gave the keynote speech at the Democratic Convention on Tuesday. He also addressed the DNC's LGBTQ caucus.

Commonwealth Court

rejected a petition from three "trans women" (biological males) to strike down a PA law prohibiting residents with serious felonies from changing their names.

The Philadelphia LGBTQ Bar Association

will be debuting new Continuing Legal Education virtual courses, which will include "Professional Inclusion: Sexual Orientation, Gender Identity, and Rule 8.4 (g), Prohibiting Discrimination" "In the Practice of Law."

In the **Fulton v. City of Philadelphia** case (Catholic Services seeking to not be forced to place children in

same-sex households) a "bipartisan group of lawmakers, child welfare advocates, faith leaders and groups as well as LGBTQ advocates" have filed 46 amicus briefs to the US Supreme Court in support of the city's discriminatory law.

News From National Scene

A **restraining order** has been issued which allows indoor services (with singing and no attendance cap!) in California churches.

In a loss for women's sports, an Idaho judge has temporarily blocked the implementation of the **Fairness in Women's Sports Act** which prevented boys who think they are girls from playing on girls' sports teams.

A Christian photographer and blogger

filed suit against the city of Louisville, KY in November 2019 citing its anti-discrimination law (homosexual special rights ordinance) violates her constitutional rights and religious beliefs. Recently U.S. District Judge Justin R. Walker wrote that Louisville cannot enforce the Fairness Ordinance on Nelson without unconstitutionally "abridging her freedom of speech."

Nebraska's governor has signed into law a bill that bans **dismemberment abortions**.

The creator of Disney Channel's animated series "**The Owl House**" recently confirmed that the 14-year-old lead character Luz Noceda is bisexual.

President Trump has pardoned, woman suffragette and pro-life advocate, **Susan B. Anthony**, for voting illegally in the 1872 presidential election. Anthony was arrested after voting in Rochester, NY, tried, found guilty and fined. Although, she never paid the \$100 fine she received and never served jail time, according to the House Office of the Historian. The National Susan B. Anthony Museum and House is outraged that the President pardoned her!
