The **Weitzman National Museum of American Jewish History in Philadelphia** has once again been vandalized. An individual scrawled an antisemitic message on the museum's *OY/YO* sculpture. In August 2025 someone spray-painted graffiti on the building, plaza, and an Israeli flag.

Open lesbian **Philadelphia Court of Common Pleas Judge Barbara McDermott** has passed away from a rare form of uterine cancer. She was first elected in 2012. She "married" her partner in 2014. Her family wrote in her obituary, "Heaven will now be well-run and much more efficient." Perhaps they should read Scripture more closely.

Philadelphia drag performer and designer **Chantal Waldorf, an illegal immigrant from Nicaragua** also known as Manuel, was detained by U.S. Immigration and Customs Enforcement (ICE) and is asking for money to pay an attorney to fight deportation. Philadelphia

City Councilmember Rue Landau, the city's first openly LGBTQ+ city councilmember, also posted a message of support.

Self-described progressive **Democrat Brandon Dukes** won the special election for PA House District 12 following the resignation of Rep. Stephanie Scialabba in March. He received support from statewide Democrats, with Lt. Governor Austin Davis and U.S. Rep. Chris Deluzio, D-17, campaigning for him. He was endorsed by pro-LGBTQ Steel City Stonewall Democrats. The seat was held by Daryl Metcalfe for more than two decades.

News from National Scene

From Libs of TikTok: Sophia Hunt, a 17-year-old Indiana high school student and president of her local TPUSA chapter, was the target of Kailly Stanich, a deranged leftist mother who allegedly verbally attacked her during a school event. Mount Anthony Middle School in Vermont has removed the display of large LGBTQ-themed flags.

The **University of Minnesota** was sued by the conservative Young America's Foundation over claims that the school's gender and pronoun policies violate students' First Amendment rights.

A Culturally and Linguistically Diverse Education teacher at **Wilson Elementary School in Colorado** allegedly was reprimanded for wearing a shirt emblazoned with "XX-XY," while attending a pre-school-year in-service day.

Under a proposed **U.S. Dept. of Education** rule, higher education accreditors may have to ditch their DEI requirements in favor of policies that value "intellectual diversity" and "academic freedom".
