A work-study job advertised at **Penn State University** wants students committed to “anti-racism practices” to help the League of Women Voters register and educate voters and the taxpayers get to pay for it! The position is offered through Penn State’s Community Service Federal Work Study Program.

Did you know **Pittsburgh** has amended the city’s Code to “shield transgender Pittsburghers from out-of-state prosecution and to deprioritize prosecution if gender-affirming care should become illegal in the Commonwealth or nationwide”?

**Rainbow Alliance** of NEPA will hold an “adult-oriented fun and friendly competition at the first annual Field Gay!” in Kirby Park in Wilkes Barre.

**Rainbow Phoenix** (Phoenixville in Chester County) is for youth ages 14-18. The meetings are facilitated by Planned Parenthood Southeast PA.

**From National Scene**

**Keller Independent School District** in Keller, TX has approved a policy to prohibit the use of pronouns that do not match students’ biological sex, regardless of their pronoun preferences or gender identity. The rule also states that parents must be alerted if their children request to go by different names or pronouns at school and that parents must write a notice granting permission for schools to call their students by alternative names or pronouns. The ACLU has sent the school a letter warning that the policy is discriminatory.

A nurse who had worked in the endocrinology clinic at **Texas Children’s Hospital** and became a whistleblower exposing the continued treatment of minors using puberty blockers and cross-sex hormones, even after Texas passed a law making such illegal, has been fired “effective immediately”.

**Montana’s Supreme Court** ruled that minors don’t need their parents’ permission to get an abortion in the state, saying such violates the privacy clause in the state constitution.

The **St. Joseph, Missouri Board of Education** voted 4-3 to retain “without restriction” the library book The Bluest Eye that had been challenged in part for a detailed account of the incestuous rape of an 11-year-old by her father.

Massachusetts Governor Maura Healey has signed into law the “**Parentage Act**” that removes words such as “mother,” “father,” “man,” and “woman,” from state law with the claim that use of these terms prevents LGBT families from achieving equality under the law.

The **American Society of Plastic Surgeons**. several of whose members are currently being sued by detransitioners, has reportedly distanced itself from the practice of providing children with so-called gender affirming care.
