Villanova University has issued guidance for faculty and staff on how to be gender-inclusive in work spaces, laboratories and classrooms. This includes using 'gender-inclusive' language, using the correct pronouns and even including a "Gender-Inclusion Statement" on any syllabus to provide students with a definition of gender inclusivity and guidance on the use of pronouns and non-sexist language in classrooms.

A former female guard at the **Coal Township State Prison** (Northumberland County) is suing the PA Dept. of Corrections, seeking in excess of \$150,000 in damages. She identifies as male and claims the facility would not allow her to use the locker room and restroom consistent with her "gender identity," misgendered her and insisted that she remove her prosthetic penis upon entering the prison.

News From National Scene
The **Fifth Circuit Court of Appeals** unanimously struck

down a Biden administration statute that forced doctors to perform medical procedures, including gender-transition procedures, against their religious beliefs.

The **lead chaplain for the Austin, TX fire department** has been fired for posts he made on his private Christian blog. The department asked him to apologize to the LGBTQ community for the posts and he refused.

Yale University has a Pediatric Gender Program which helps children as young as 3 years old with their "gender journeys" through medical interventions.

Tennessee now bans abortion. Businesses in Davidson County or its county seat, Nashville, that want special tax breaks must now "report" whether or not they cover the costs of employees traveling out of state for an abortion.

Congresswoman **Marjorie Taylor Green** has introduced the **Protect Children's Innocence Act**, which would prohibit so-called "gender affirmation care" for minors.

The **San Diego Unified School District** teachers are instructed to break the

"gender binary" and dismantl "heteronormativity" in their classrooms.

An 80 year-old Washington state woman has been **banned from using the pool at her local YMCA** for complaining about a biological male being in the women's locker room. Staff assured the 80 year-old that it was really a woman!

Harpeth Hall, an elite, private all-girls school in Nashville, TN, will now allow any student who identifies as a girl to apply to attend.

Keller Independent School District, near Fort Worth, TX, has instructed the schools in the district to remove 40 "controversial" books. Among the list of truly controversial books like "Gender Queer" is the Bible!
